Government of Nepal has received a grant from *the World Bank* towards the cost of *Forest for Prosperity Project* and intends to apply part of the funds to cover eligible payments under the Contract for *Drone*. Bidding is open to all eligible Bidders from all countries as defined in *The World Bank's Procurement Regulations for IPF Borrowers, July 2016(Revised February 2025)*.
2. The Forest Directorate now invites Sealed Bids from eligible Bidders for the **Procurement of Drone** to be procured under National competitive bidding–Single stage-single envelope procedures.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Forest Directorate, during office hours, at the address given below.
4. A complete *set* of Bidding Documents may be purchased from the office *of Forest Directorate, Butwal, Lumbini* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 3,000.00 till 10 June 2026 during office hours.

5. Sealed bids must be submitted to the office *of Forest Directorate, Butwal* by hand on or before **12.00 hrs on 11 June 2026**. Bids received after this deadline will be rejected.
6. Pre-bid meeting shall be held on 27 May 2026 at the address given below at 14.00 hrs.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend 12.00 hrs on 11 June 2026 at the office of *Forest Directorate, Butwal*. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security, amounting to a minimum of NRs. **108,000.00**, which shall be valid for 30 days beyond the validity period of the bid 08 October 2026.

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
